



**Authority:** [49 CFR 26.49\(a\)\(4\)](#) requires FTA recipients to report vehicle procurement awards.

### What is a Transit Vehicle Manufacturer (TVM)?

- Any manufacturer whose primary business purpose is to build vehicles specifically for public mass transportation.
  - Includes but not limited to busses, rail cars, trolleys, ferries, and vehicles manufactured specifically for paratransit purposes.
- Producers of vehicles that receive post-production alterations or retrofitting to be used for public transportation purposes.
- Note: Businesses that manufacture vehicles solely for personal use and for sale “off the lot” are **not** considered transit vehicle manufacturers.

### Paratransit Definition:

- Paratransit definition includes producers of vehicles that receive post-production alterations or retrofitting to be used for public transportation purposes.
- Businesses that manufacture vehicles solely for personal use and for sale "off the lot" are not considered transit vehicle manufacturers ([49 CFR 26.5](#)).

### What is YOUR [subrecipient] responsibility when reporting vehicle purchases?

- As stated in the Project Agreement:
  - If the SUBRECIPIENT will purchase one or more transit vehicles (excluding unmodified mass-produced vans or unmodified pop-top vans), it assures that it will obtain from each transit vehicle manufacturer a TVM certification, to show that the manufacturer complies with DBE requirements.

**What is the DOT&PF [recipient] responsibility when reporting vehicle purchases?**

- The 2014 DBE regulation updates require FTA recipients to report transit vehicle procurement awards. Effective November 2014, FTA recipients are required to submit, within 30 days of making an award, the name of the successful bidder and the total dollar value of the contract.
- Remember, only eligible TVMs may bid on FTA-assisted transit vehicle procurements.

**How does a subrecipient know if they are required to submit a vehicle purchase?**

- The following project Reimbursable Grant/Project Agreement are required to submit purchases:
  - 5303, 5309, 5339(c), 5339
  - 5310, 5311 f, 5311: CRRSAA IFA, 5311: CARES, 5311 – CRRSAA, STP 5311

**Where can I find the eligible list of all current Transit Vehicle Manufacturers (TVM)?**

**When should the subrecipient submit this report?**

- Submit all vehicle purchases within 15 days of award.
