## DOT&PF Notice of Floodplain Encroachment: Revilla and Gravina Airport Ferry Terminals

The Alaska Department of Transportation and Public Facilities (DOT&PF) is proposing to construct new ferry berths and related upland improvements at the Revilla and Gravina airport ferry terminals.

Specific project components that would encroach into the base floodplain include the placement of fill, portions of the bulkhead retaining wall at the Revilla New Ferry Berth (SFHWY00085), marine structures, and pile driving activities in marine waters.

- SFHWY00085 - Unmapped, 0200030001B
- SFHWY00109 - Unmapped

The encroachments are expected to have an insignificant effect on water flows and flood flow elevation in Tongass Narrows, thus significant encroachments are not anticipated. Additionally, no longitudinal encroachments are anticipated.
