The *Alaska Highway Preconstruction Manual (HPCM)* is modified as follows:

1. Page 1100-15 is deleted and replaced with the attached Table 1100-1
2. Figure 1100-3 is replaced with the attached version

These changes are effective November 15, 2016. Projects with design approval prior to December 15, 2016 are not required to use the new design standards. Reference to different versions of these design standards in the HPCM are superseded by this memorandum.
